

**ORDER**

20/04/2015      The Superintendent of Police, Ramgarh has issued a letter no.- 1989/Crime Sec. on dated 12/08/2013 for initiation of confiscation proceeding U/S 6(A) of E.C. Act against the accused Ram Odgar Sao, S/o Lt. Sagar Sao, Ram Pukar Sao, S/o Lt. Sagar Sao, Upendra Kumar Sao, S/o Ram Udgari Sao, Ashish Kumar Sao, S/o Ram Pukar Sao, all Resident of Village- Patratu Basti, Near Durga Mandir, P.S.- Ramgarh, Dist.- Ramgarh. Thereafter notice was issued to all the accused U/S 6(B) of E.C. Act.

The Superintendent of Police, Ramgarh has submitted in his report that in Ramgarh P.S. Case no.- 177/13, Dated 24/06/2013, U/S 7 of E.C. Act regarding confiscation of seized 191 bags of Subsidy Rice having 50 kg each kept in the sealed & printed as F.C.I. were being carried out for black Marketing.

The opposite party has submitted in his show-cause that the opposite party member has purchased 200 bags of rice each having 50 Kg. rice from Dashari Rice Tech. of Village- Badulia, PO.- Sagrai, District- Burdwan on 20-06-2013, bearing Tax Invoice No.- 209 on payment of 2000/- Rupees per quintal. The opposite party has prayed to drop the proceeding.






From perusal of the case records recommendation of Superintendent of Police, Ramgarh, It is clear that on 24/06/2013 at Village- Patratu Basti, P.S.- Ramgarh, Dist.- Ramgarh, 191 bags of subsidy Rice having 50 kg each kept in the sealed bag printed as F.C.I. were being carried out for black Marketing, which was seized by Police concerned in Ramgarh P.S. Case No.- 177/13, Dated 24/06/2013. Hence, it is here by ordered that 191 bags of Rice seized by police is confiscated. proceeding is concluded.
