ORDER

10.02.25 This case has been filed as Miscellaneous Appeal Case No.11/2022, against the order of Land Reforms Deputy Collector (LRDC), Bagodar Sariya in Miscellaneous Case No.06/2019-20, Md Hanif Ansari and Others vs Majid Ansari and Others and State, order dated 23.12.2020.

The land in question pertains to Mauza- Banpura, Thana No.113, Khata No.24, Plot No.13, 62 total area measuring 10 acres, 82.50 decimal in Bagodar Circle. LRDC Bagodar Sariya has mentioned in his order that according to the report submitted by Circle Officer, Bagodar through his letter no.228, dated 25.02.2020, it has been stated that Hanif Ansari, son of Talo Miyan has submitted an application regarding the rectification in Register II on the basis of partition and ownership over the land, mentioning the genealogical table. And that as per letter no.942, dated 07.11.2020 and letter no.998, dated 24.11.2020 of Circle Officer Bagodar, ancestors of both khatiyaans raiyats have partitioned the land in half share each and have possession over it and are doing 'jot-aabaad' over it.

Circle Officer has recommended to enter the names of left over khatiyaani raiyats in Register II on the basis of Khatiyaan, share and jot-aabaad/ possession. Land Reforms Deputy Collector (LRDC), Bagodar Sariya has also ordered the Circle Officer Bagodar for the same.

Heard the Ld. GP on various points of submission made by both the parties and on other points available in the case record. On account of the aforementioned and matters

mentioned in the LCR of LRDC Bagodar Sariya and CO Bagodar, points and arguments submitted/ given by Ld. Advocates of both parties, opinion of Ld. G.P. and upon perusal/ examination of the various documents available on record, the court comes to the conclusion that there is no need of any interference or revision in the order of Land Reforms Deputy Collector, Bagodar Sariya. Thus the present Miscellaneous Appeal is rejected and this case stands disposed of.

Let a copy of this order be provided to both parties and all concerned. Due to busy schedule in law and order and other administrative work this order is passed today.
