ORDER

Received the case record of the instant case today. The case record has been put before me alongwith a petition filed on by the above named accused praying inter-alia to refund of Rs.75,000/- (Rupees Seventy Five Thousand Only) to the accused/petitioner in the light of order dated 07.08.2017 passed by the Food Safety Commissioner in Appeal No.-01/2016 (Sanat Kumar Guin Vs The State of Jharkhand) arising out of the instant FS&S Case No.-12/2014-15.

On going through the record, I find that, the learned predecessor Adjudicating Officer – Cum – Deputy Commissioner, Ranchi vide his order dated 26.03.2016 the above named accused was found guilty of offence U/s 50 & 54 of the Act of 2006 and according penalty of Rs.1,00,000/- (Rupees One Lakhs Only) was imposed upon the accused.

According to the accused he has deposited the aforesaid penalty vide DD No.-228330 dated 03.05.2016 of the Allahabad Bank, Ranchi.

In an appeal preferred by the above named accused against the aforesaid order in the instant case being registered as Appeal No -01/2016, the Learned Food Safety Commissioner vide its order dated 07.08.2017 has reduced the penalty levied by the Adjudicating Officer from Rs.1,00,000/- (Rupees One Lakhs Only) to Rs.25,000/- (Rupees Twenty Five Thousand Only).

Hence under the facts and circumstances mentioned above, the Deputy Collector, Nazarat Section, Ranchi is directed to refund the Rs.75,000/- (Rupees Seventy Five Thousand Only) to the accused on proper identification and verification.

Communicate this order to the DFSO-CUM- DO-CUM ACOMO-1, Ranchi and Deputy Collector, Nazarat Section, Ranchi for information and necessary action.
