

Dhurwa (Tupudana), District Ranchi to notify his movement and report himself daily in concerned Police Station</p> <p>As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Doranda P.S. Case No.-160/2005 dated 31.05.2005 U/s 392 IPC, (2) Khunti PS Case No.-3/2015 U/s 414/34 IPC, (3) Dhurwa (Tupudana) PS Case No.-31/13 dated 27.02.2013 U/s 11 Prevention of Cruelty to Animals Act, 1960 and 12/13 Bovine Animal Prohibition of Slaughter Act. 2005, (4) Dhurwa (Tupudana) PS Case No.-284/12 dated 04.12.2012 U/s 302/34 IPC, (5) Tupudana PS Station Diary No.-33/2016 dated 21.12.2016 and (6) Tupudana PS Station Diary No.-20/2016 dated 26.12.2016</p> <p>Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and</p>

since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2016, hence I do not find it reasonable to proceed with the proposal made against the Opp. Party at this juncture and so, for the reasons aforementioned, the instant proceeding against the Opp. Party is dropped. However the police has liberty to forward fresh proposal against the Opp. Party as per the provisions laid under the Jharkhand Control of Crime Act, 2002 (Adopted) on new grounds.
