Case No.-1106/2013 dated 11.12.2013 U/s 386/419/420/467/471/414/120B/34 IPC (2) Sukhdeonagar PS Station Diary No.-32/2017 dated 03.01.2017 and (3) Sukhdeonagar PS Station Diary No.-36/2017 dated 05.01.2017</p> <p>Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2017, hence I do not find it reasonable to proceed with the proposal made against the</p>
