ORDER

A proposal U/s 3 (1) (a), 3 (1) (b) (1) of the Jharkhand Control of Crime Act, 2002 (Adopted) has been received from the Senior Superintendent of Police, Ranchi vide Letter No.-2927/DCB dated 27.11.2017 for a direction upon the anti-social element namely Janak Pandey Son of Jitu Pandey, R/o Balumath, P.S. Balumath, District Latehar, at present residing at C/o Manoj Shukla Son of Ram Manohar Shukla, CCL Colony, Bank of India, Near Khelari Police Station, P.S. Khelari, District Ranchi to remove himself outside the Ranchi District.

As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Khelari P.S. Station Diary No.-24/2017 dated 15.09.2017, (2) Khelari P.S. Station Diary No.-08/2017 dated 19.09.2017, (3) Mccluskieganj P.S. Station Diary No.-14/2017 dated 20.09.2017, (4) Mccluskieganj P.S. Station Diary No.-20/2017 dated 20.09.2017

Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp.
