ORDER

A proposal U/s 3 (1) (a), 3 (1) (b) (1) of the Jharkhand Control of Crime Act, 2002 (Adopted) has been received from the Senior Superintendent of Police, Ranchi vide Letter No.-3057/DCB dated 15.12.2017 for a direction upon the anti-social element namely Rajkumar Singh @ Gollu Singh Son of Gopal Singh R/o Road No.-7, Hill View Road, Bariatu, District Ranchi to notify his movement and report himself daily in concerned Police Station.

As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Bariatu PS Case No.- 255/2014 dated 06.07.2014 U/s 147/148/149/323/325 /326/307 of IPC and 25 (1-B)A/26/35 Arms Act, (2) Bariatu PS Case No.- 257/2014 dated 06.07.2014 U/s 147/148/149/323/324 /341/594/506/307/386/120(B)A of IPC and 26/36/27 Arms Act, (3) Bariatu PS Station Diary No.-35/2017 dated 04.12.2017, (4) Bariatu PS Station Diary No.-22/2017 dated 05.12.2017, (5) Bariatu PS Station Diary No.-28/2017 dated 05.12.2017, (6) Bariatu PS Station Diary No.-23/2017 dated 05.12.2017, (7) Bariatu PS Station Diary No.-30/2017 dated 06.12.2017, (8) Bariatu PS Station Diary No.-30/2017 dated 07.12.2017, (9) Bariatu PS Station Diary No.-21/2017 dated 07.12.2017, (10) Bariatu PS Station Diary No.-31/2017 dated 07.12.2017, (11)

Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2018, hence I do not find it reasonable to proceed with the proposal made against the Opp. Party at this juncture and so, for the reasons aforementioned, the instant proceeding against the Opp. Party is dropped. However the police has liberty to forward fresh proposal against the Opp. Party as per the provisions laid under the Jharkhand Control of Crime Act,2002 (Adopted) on new grounds.

Communicate the order to the Senior Superintendent of Police, Ranchi for information and necessary action.
