ORDER

A proposal U/s 3 (1) (a), 3 (1) (b) (1) of the Jharkhand Control of Crime Act, 2002 (Adopted) has been received from the Senior Superintendent of Police, Ranchi vide Letter No.-3107/DCB dated 28.12.2017 for a direction upon the anti-social element namely Md Chand Hussain S/o Sher Muhammad, R/o Churi Tola, P.S. Kanke, District Ranchi to notify his movement and report himself daily in concerned Police Station.

As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Kotwali PS Case No.-212/2017 dated 08.08.2017 U/s 356/382 of IPC (Charge Sheet No.-209/2017 has been submitted upon the matter), (2) Kotwali PS Case No.-213/2017 dated 08.08.2017 U/s 356/382 of IPC, (3) Kotwali PS Station Diary No.-47/2017 dated 07.12.2017, (4) Kotwali PS Station Diary No.-41/2017 dated 08.12.2017.

Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2017, hence I do not

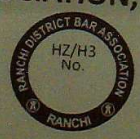
