ORDER

A proposal U/s 3 (1) (a), 3 (1) (b) (1) of the Jharkhand Control of Crime Act, 2002 (Adopted) has been received from the Senior Superintendent of Police, Ranchi vide Letter No.-3132/DCB dated 31.12.2017 for a direction upon the anti-social element namely Suraj Ram @ Suraj Chapta S/o Suresh Ram, R/o Nayadhoda, P.S. Khelari, District Ranchi to notify his movement and report himself daily in concerned Police Station.

As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Khelari PS Case No.-31/2002 dated 20.04.2002 U/s 394 of IPC (2) Khelari PS Case No.-112/2007 dated 05.12.2007 U/s 452/352/34 of IPC, (3) Khelari PS Case No.-113/2007 dated 06.12.2007 U/s 25 (1-B)A/26/35 Arms Act, (4) Khelari PS Case No.-85/2010 dated 11.12.2010 U/s 147/148/149/386/120B of IPC and 25(1-B)A/26/35 Arms Act and 17 C.L.A. Act and 13 U.P.A Act, (5) Khelari PS Case No.-81/2017 dated 10.10.2017 U/s 341/323/326/307/504/506 of IPC, (6) Khelari PS Station Diary No.-14/2017 dated 06.12.2017, (7) Khelari PS Station Diary No.-16/2017 dated 17.12.2017

Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to

notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2017, hence I do not find it reasonable to proceed with the proposal made against the Opp. Party at this juncture and so, for the reasons aforementioned, the instant proceeding against the Opp. Party is dropped. However the police has liberty to forward fresh proposal against the Opp. Party as per the provisions laid under the Jharkhand Control of Crime Act,2002 (Adopted) on new grounds.

Communicate the order to the Senior Superintendent of Police, Ranchi for information and necessary action.
