Nagri District Ranchi to notify his movement and report himself daily in concerned Police Station.</p> <p>As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Nagri PS Case No- 57/2016 dated 03.04.2016 U/s 147/148/149/307/353 / 399/402/120B IPC and 25 (1-B)/26/27/35 Arms Act (2) Nagri O.P. Station Diary No.-21/2017 dated 05.12.2017</p> <p>Having gone through the material available on record, I find that as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 5 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2017, hence I do not find it reasonable to proceed with the proposal made against the Opp. Party at this juncture and so, for the reasons</p>
