Opp. Party</p> <p style="text-align: center;">ORDER</p> <p>A proposal U/s 3 (1) (a), 3 (1) (b) (1) of the Jharkhand Control of Crime Act, 2002 (Adopted) has been received from the Senior Superintendent of Police, Ranchi vide Letter No. 85/DCB dated 13.01.2017 for a direction upon the anti-social element namely Anis Khan @ Anis Surya Son of Late Abdul Samad Khan, R/o Nala Road Gali No. B-9, Hazi Subhan Gali, P.S. Hindpiri, District Ranchi to notify his movement and report himself daily in concerned Police Station.</p> <p>As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Kotwali PS Case No.-15/2017 dated 27.01.2017 U/s 379/411 IPC (2) Kotwali P.S. Case No. 18/2017 dated 01.02.2017 U/s 370/411 IPC (3) Hindpiri PS Case No. 26/2017 dated 17.03.2017 U/s 413/414 IPC (4) Kotwali PS Station Diary No. 36/2018 dated 05.01.2018 and (5) Kotwali PS Station Diary No. 38/2018 dated 06.01.2018.</p> <p>Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates to the year 2018, hence I do not find it reasonable to proceed with the proposal made against the Opp. Party at this juncture and so, for the reasons aforementioned, the instant proceeding against the Opp. Party is dropped.</p> |  |
