ORDER

A proposal U/s 3 (1) (a), 3 (1) (b) (1) of the Jharkhand Control of Crime Act, 2002 (Adopted) has been received from the Senior Superintendent of Police, Ranchi vide Letter No.-90/DCB dated 15.01.2018 for a direction upon the anti-social element namely Vikash Kumar Singh Son of Surendra Singh, R/o Lakshmi Nagar, P.S. Pandra, District Ranchi to notify his movement and report himself daily in concerned Police Station.

As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Kotwali (Pandra OP) PS Case No.-1161/2013 dated 26.12.2013 U/s 341/323/379/34 IPC, (2) Sukhdeonagar (Pandra OP) PS Case No.-07/2016 dated 06.01.2016 U/s 147/148/149/443/323/324/325/379/427/504/506 of IPC, , (3) Sukhdeonagar (Pandra OP) PS Case No.-101/2016 dated 17.02.2016 U/s 25 (1-B)A/26/35 Arms Act (4) Pandra O.P. Station Diary No.-17 dated 27.07.2016, (5) Pandra O.P. Station Diary No.-21 dated 28.07.2016, (6) Pandra O.P. Station Diary No.-34 dated 23.12.2017 and (7) Pandra O.P. Station Diary No.-26 dated 27.12.2017

Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can

be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2017, hence I do not find it reasonable to proceed with the proposal made against the Opp. Party at this juncture and so, for the reasons aforementioned, the instant proceeding against the Opp. Party is dropped. However the police has liberty to forward fresh proposal against the Opp. Party as per the provisions laid under the Jharkhand Control of Crime Act, 2002 (Adopted) on new grounds.
