Ormanjhi, District Ranchi to notify his movement and report himself daily in concerned Police Station.</p> <p>As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Ormanjhi PS Case No.-11/2017 dated 26.01.2017 U/s 393 of IPC, (2) Ormanjhi PS Station Diary No.-32/2018 dated 06.12.2017, (3) Ormanjhi PS Station Diary No.-22/2018 dated 09.12.2017, (4) Ormanjhi PS Station Diary No.-32/2017 dated 10.12.2017 and (5) Ormanjhi PS Station Diary No.-31/2017 dated 14.12.2017</p> <p>Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2018, hence I do not</p>
