The instant proceeding has been initiated upon the request of the Special Officer Rationing, Ranchi vide its Letter No-520(ii) dated 25.05.2017 for confiscation of 3.5 Quintals of rice and Mahindra Pickup Van having Registration No.-JH 01 AN 4632 seized in connection with Lapung PS Case No.-13/2017 dated 28.04.2017.

On perusal of report submitted by the Special Officer Rationing, Ranchi, I find that, on 28.04.2017 after receiving information from the general Villagers, the armed police of Lapung Police Station caught the aforesaid Mahindra Pick Up Van having Registration No.-JH 01 AN 4632 laden with 3.5 Quintals of rice in Village Barkakura near Bokranda Tungri. On enquiry the driver of the said vehicle said that he had loaded the said rice from the PDS shop of the Opp Party Chandra Sahu and since the driver of said vehicle was unable to give satisfactory answer and produce documents regarding procurement of the aforementioned rice, hence the police seized the said Vehicle and rice loaded with 3.5 Quintals of rice and accordingly Lapung PS Case No.-13/2017 dated 28.04.2017 was lodged by the BSO, Lapung.
