ORDER

The instant proceeding has been initiated upon the request of the Special Officer Rationing, Ranchi vide its Letter No.-884(ii) dated 23.09.2017 R/w Letter No.-927 dated 10.10.2017 for confiscation of 11 Quintals of rice seized in connection with Ormanjhi PS Case No.-1,18/2017.

On perusal of report submitted by the Special Officer Rationing, Ranchi, I find that, while investigation with respect of the rice laden on Tata 407 Truck No.-JH01 AV-9729 kept in the premises of Ormanjhi police station vide DR No.-2329/2017, the driver of the Vehicle Md Asraf admitted in written that the Assistant Godown Manager and Transporting Contractor Sri Vikash Jaiswal directed him to load 30 Quintal of rice from the Ormanjhi Godown and drop the same upon his vehicle to Village Chakla and after loading the same in his vehicle, he went to have breakfast and does not know what happened thereafter. According to the driver only he had loaded on 62 packets containing 30 quintals of rice in his vehicle, but on perusal of the challan it appears that Challan No.-29 Part was issued in the name of PDS shop owner Md Asraf for 30.20 quintals of rice and Challan No.-30 was issued in the name of Aziz Ansari for

11 Quintals of rice. Both the challans are suspicious as the PDS Shop Owner Azim Ansari is entitled for 59.20 Quintals of rice and as per the norms, entire rice allotted to a PDS shop should be dispatched in a single lot and not in parts and so it is beyond doubt that 11 quintals out of the 41.20 Quintals were loaded in the said truck by the AGM and Contractor with a view of black marketing.

Further according to the Marketing Officer, 30.20 quintals of rice, which was issued in the name Aziz Ansari was handover to him and so proposal for consication of 11 quintals of rice has been made by him.

Even on issuance of proper notice no one appeared on behalf of the Opp. Party to argue this case, hence after hearing the State, the instant case was fixed for passing final order

Having heard both the State and on perusal of report submitted by the Learned Special Officer Rationing, Ranchi I find that, the Opp. Party in connivance with the contractor has loaded extra 11 quintals of rice upon Tata 407 Truck No.-JH01 AV-9729 behind the back of the driver for the purpose of black marketing. Hence let the 11 Quintals of rice seized in connection with Ormanjhi PS Case No.-118/17 be confiscated.

Communicate this order to the Special Officer Rationing, Ranchi for information and necessary action.
