Opp. Party</p> <p style="text-align: center;">ORDER</p> <p>A proposal U/s 3 (1) (a), 3 (1) (b) (1) of the Jharkhand Control of Crime Act, 2002 (Adopted) has been received from the Senior Superintendent of Police, Ranchi vide Letter No.-755/DCB dated 04.05.2018 for a direction upon the anti-social element namely Chotu Khan S/o Md Tauhid Khan, R/o Sattar Colony, P.S. Bariatu, District Ranchi to notify his movement and report himself daily in concerned Police Station.</p> <p>As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Sadar PS Case No.-231/2014 dated 21.06.2014 U/s 307/34 of IPC and 27 Arms Act, (2) Sadar PS Case No.-523/2015 dated 15.11.2015 U/s 147/148/149/341/323/307/379/427/504 of IPC, (3) Sadar Station Diary No.-16/2018 dated 28.03.2018, (4) Sadar PS Station Diary No.-14/2018 dated 29.03.2018.</p> <p>Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2018, hence I do not</p>
