Opp. Party</p> <p style="text-align: center;">ORDER</p> <p>A proposal U/s 3 (1) (a), 3 (1) (b) (1) of the Jharkhand Control of Crime Act, 2002 (Adopted) has been received from the Senior Superintendent of Police, Ranchi vide Letter No.-823/DCB dated 09.05.2018 for a direction upon the anti-social element namely Anshu Sharma Son of Makhan Sharma, R/o Jora Talab Road, P.S. Bariatu, District Ranchi to notify his movement and report himself daily in concerned Police Station.</p> <p>As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Bariatu PS Case No.-257/2014 dated 06.07.2014 U/s 147/148/149/323/341/504/506/307/386/120B of IPC and 25 (1-B)A/26/35/27 Arms Act, (2) Bariatu PS Case No.-255/2014 dated 06.07.2014 U/s 147/148/149/323/324/325/326/307 of IPC and 25 (1-B)A/26/35/27 Arms Act, (3) Bariatu PS Case No.-219/2012 dated 05.09.2012 U/s 387/34 of IPC, (4) Bariatu PS Case No.-290/2012 dated 01.09.2011 U/s 147/148/149/302 of IPC and 27 Arms Act, (5) Bariatu PS Case No.-106/2015 dated 12.03.2015 U/s 341/323/307/504/506/386/387/427/34 of IPC, (6) Bariatu PS Station Diary No.-16/2018 dated 14.03.2018, and (7) Bariatu PS Station Diary No.-24/2018 dated 13.03.2018</p> <p>Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation</p>
