A proposal U/s 3 (1) (a), 3 (1) (b) (1) of the Jharkhand Control of Crime Act,2002 (Adopted) has been received from the Senior Superintendent of Police, Ranchi vide Letter No.-1663/DCB dated 30.10.2018 for a direction upon the anti-social element namely Krishna Toppo Son of Late Balwant Toppo R/o Harihar Singh Road, P.S. Bariatu, District Ranchi to notify his movement and report himself daily in concerned Police Station.

As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Bariatu PS Case No.-231/2017 dated 02.08.2017 U/s 290 of IPC and 47 (A) Excise Act, (2) Bariatu PS Station Diary No.-27/2018 dated 06.10.2018 and (3) Bariatu PS Station Diary No.-23/2018 dated 11.10.2018

Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates to the year 2018, hence I do not find it reasonable to proceed with the proposal made against the Opp.
