ORDER

A proposal U/s 3 (1) (a), 3 (1) (b) (1) of the Jharkhand Control of Crime Act, 2002 (Adopted) has been received from the Senior Superintendent of Police, Ranchi vide Letter No.-531/DCB dated 01.04.2018 for a direction upon the anti-social element namely Sahil Ansari @ Bonus Son of Late Kalam Ansari R/o Kantatoli, Tamtam Toli, Opp. to Tirkey Complex, P.S. Lowerbazar, District Ranchi to notify his movement and report himself daily in concerned Police Station.

As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Lower Bazar PS Case No.-79/2010 dated 21.04.2010 U/s 457/379/511 of IPC and Charge Sheet No.-93/2010 dated 30.04.2010 has been submitted upon the matter, (2) Lower Bazar PS Case No.-205/2015 dated 28.05.2015 U/s 419/420/467/468/471/414/34 of IPC and charge sheet no.-169/15 dated 11.07.2015 has been submitted upon the matter, (4) Lower Bazar PS Station Diary No.-44/2017 dated 12.10.2017 and (5) Lower Bazar PS Station Diary No.-35/2017 dated 29.11.2017 and (6) Lower Bazar PS Station Diary No.-44/2018 dated 13.03.2018

Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to

notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2018, hence I do not find it reasonable to proceed with the proposal made against the Opp. Party at this juncture and so, for the reasons aforementioned, the instant proceeding against the Opp. Party is dropped. However the police has liberty to forward fresh proposal against the Opp. Party as per the provisions laid under the Jharkhand Control of Crime Act,2002 (Adopted) on new grounds.

Communicate the order to the Senior Superintendent of Police, Ranchi for information and necessary action.
