Doranda, District Ranchi to notify his movement and report himself daily in concerned Police Station.</p> <p>As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Doranda PS Case No.-711/2014 dated 07.12.2014 U/s 85 of IPC and 25(1-B)A Arms Act (2) Doranda PS Station Diary No.-11/2016 dated 21.12.2011 (3) Doranda P.S. Station Diary No.- 25/2017 dated 04.12.2017 (4) Doranda P.S. Station Diary No.- 16/2018 dated 15.03.2018</p> <p>Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2018, hence I do not</p> | |
