Tamar, District Ranchi to notify his movement and report himself daily in concerned Police Station.</p> <p>As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Tamar PS Case No.-3/1999 dated 06.01.1999 U/s 394 of IPC (2) Tamar PS Case No.-18/1999 dated 27.02.1999 U/s 395/411 IPC, (2) Tamar PS Case No.-2/2008 dated 12.01.2008 U/s 395/397/412 of IPC (4) Tamar PS Station Diary No.-15/2018 dated 19.03.2018, (5) Tamar PS Station Diary No.-18/2018 dated 20.03.2018</p> <p>Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2018, hence I do not</p>
