Present appeal U/s 16 of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 has been preferred by Sri Kirti Bikram Son of Sri Bimla Charan Sharma, Resident of Lakhraj Gali, Morabadi, P.S. Bariatu, District Ranchi against (1) Professor Bimla Charan Sharma Son of Late Rup Narayan Sharma Resident of Old Age Home, Room No.-304, DAV Nandraj School Premises, Bariatu, Ranchi and (2) Keshri Vikram Son of Bimla Charan Sharma R/o Lakhraj Gali, Morabadi, P.S. Bariatu, District Ranchi on being aggrieved by and dissatisfied with order passed by the Learned Sub-Divisional Officer, Sadar, Ranchi in MAWOPASC Case No.-01/2018, wherein and whereunder the Learned SDO, Sadar, Ranchi has directed the appellant to pay the respondent no.-1 Prof. Bima Charan Sharma a sum of Rs.10,000/- (Rupees Ten Thousand Only) Per Month as maintenance till his life time.


Maintenance and Welfare of Parents and Senior Citizens Act, 2007, I find that an appeal U/s 15 of the Act of 2007 shall lie before the Appellate Tribunal notified by the State Government in the Official Gazette, but in case at hand, the appellant has failed to bring on record any such notification issued by the State Government regarding formation of the Appellate Tribunal by the State of Government.

Hence under the facts and circumstances mentioned above, it appears that the instant appeal is not maintainable before this court and so the same is dropped as not maintainable at the admission stage itself.
