ORDER

A proposal U/s 3 (1) (a), 3 (1) (b) (1) of the Jharkhand Control of Crime Act, 2002 (Adopted) has been received from the Senior Superintendent of Police, Ranchi vide Letter No.-693/DCB dated 18.07.2019 for a direction upon the anti-social element namely Shakil Ansari @ Ballu @ Ballu Ansari Son of Hazrat Ansari, R/o Basil, P.S. Nagri, District Ranchi to notify his movement and report himself daily in concerned Police Station.

As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Nagri PS Case No.-30/2015 dated 24.02.2015 lodged U/s 376/379 of IPC, (2) Nagri PS Case No.-78/2017 dated 31.07.2017 lodged U/s 354/354A of IPC, (3) Nagri PS Station Dairy No.-21/2019 dated 06.07.2019, (4) Nagri PS Station Diary No. 17/2019 dated 10.07.2019 and change sheet in the aforesaid matter has also been submitted against him.

Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation for initiation of proceeding under Act of 2002 against the Opp. Party are old and relates prior to the year 2019, hence I do not find it reasonable to proceed with the proposal made against the Opp. Party at this juncture and so, for the reasons aforementioned, the instant proceeding against the Opp. Party is
