Nagri, District Ranchi to notify his movement and report himself daily in concerned Police Station.</p> <p>As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Ratu (Nagri) PS Case No.-133/2008 dated 07.07.2008 lodged U/s 147/148/149/307/353/323/427/337/116/341/135A of IPC, (2) Ratu (Nagri) PS Case No.-134/2008 lodged U/s147/148/149/323/427/379 IPC (3) Nagri P.S. Case No. 71/2010 dated 01.01.2010 U/S 386/387 IPC, (4) Nagri P.S. Case No. 12/2012 dated 02.02.2012 U/S 385/386 IPC, (5) Nagri P.S. Case No. 66/2013 dated 07.05.2013 U/S 385/387 IPC, (6) Nagri P.S. Case No. 154/2016 dated 10.12.2016 U/S 385/387/34 IPC and section 25(1-B)A/26/35 Arms Act (7) Nagri P.S. Case No. 119/2018 dated 29.07.2018 U/S 25(1-B)A/26 Arms Act and change sheet in the aforesaid matter has also been submitted against him.</p> <p>Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation</p>
