Namkum, District Ranchi to remove himself outside the district of Ranchi .</p> <p>As per the report submitted by the Senior Superintendent of police, the opp. party has been made accused in (1) Namkum P S Case No.-128/2006 dated 07.08.2006 U/s 399/402 of IPC and 25(1-B)A/26/35 of Arms Act, (2) Namkum PS Case No.-14/2012 dated 28.01.2012 U/s 147/148/149/387/302 of IPC, (3) Namkum PS Case No.-154/2006 dated 23.09.2006 U/s 392 of IPC, (4) Namkum PS Case No.-126/2006 dated 03.08.2006 U/s 392 of IPC, (5) Namkum PS Case No.-161/2006 dated 11.10.2006 U/s 394/411 IPC, (6) Namkum PS Case No.-100/2006 dated 26.06.2007 U/s 395 of IPC, (7) Namkum PS Case No.-163/2016 dated 22.06.2016 U/s 395/412 of IPC, (8) Namkum PS Station Diary No.-20 dated 16.09.2019 and (9) Namkum PS Station Diary No.-33 dated 23.09.2019.</p> <p>Having gone through the material available on record, I find that, as per Section 3 of the Act of 2002, the direction to notify movement of the Opp. party and report himself daily can be issued for a maximum period of 6 months only at a time and since the cases forming the basis for making recommendation</p>
